Aspiring performers will enroll in a 10 week drama program that will help to develop self-confidence and improve communication skills. As students stage a small scale musical, they will be both challenged and encouraged to explore their creative potential in a non-competitive environment.

Each week, students will engage in acting exercises, theater games, ensemble singing, and movement. This session is an introduction to **K.I.D.S.** and will focus on the process of theatre in preparation for the regular 16 week K.I.D.S. program for grades 3, 4, & 5. The 10 week Mini K.I.D.S. program will culminate with family and friends invited to the final class for a performance of **SQUIRM!**

Mr. Boehm has choreographed *Rent* and *Spring Awakening* at DC's Keegan Theatre. Kurt has performed at the Kennedy Center, Signature Theatre, Arena Stage, Ford's Theatre, & Adventure Theatre. 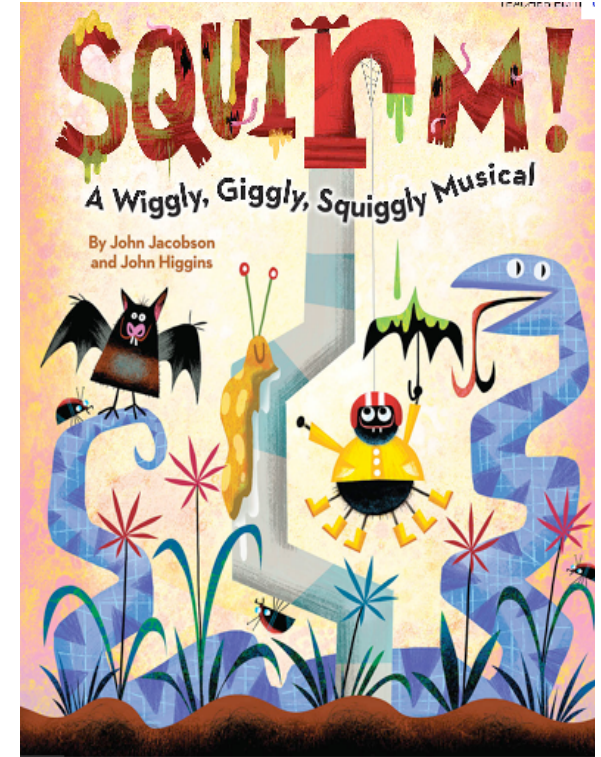
